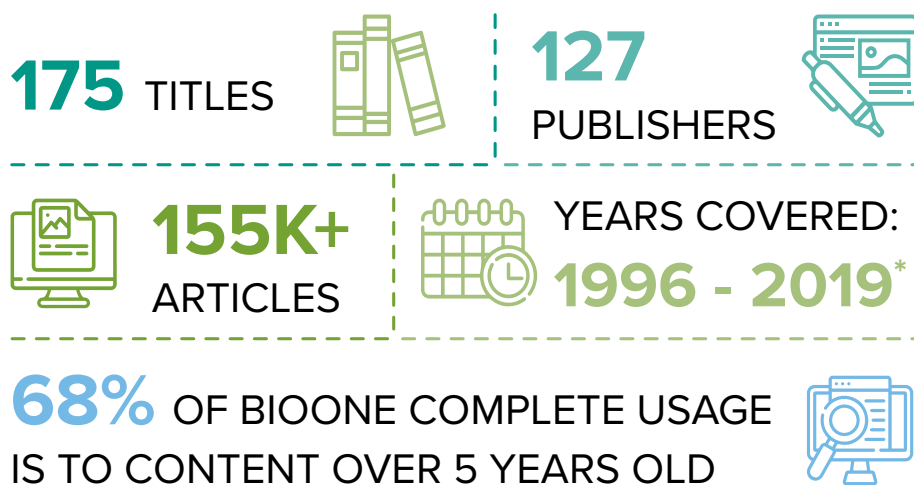


## Permanent Access to Enduring Research

Featuring titles such as *Annals of the Entomological Society of America*, *Journal of Zoo and Wildlife Medicine*, *Avian Diseases*, *Weed Technology*, *Journal of Paleontology*, *Journal of Herpetology*, *American Biology Teacher*, and *Waterbirds*, this collection provides context for long-term ecological and environmental trends, and the ongoing study of organismal biology.
