Lechon intitulé «Evaluation de la pluie de graines d'arbres isolés dans les cultures vivrières en région de forêt tropicale humide du Mayombe (Congo Méridional)» publié dans *Candollea* (2009) 64(2): 219-235. Cet article reprend des paragraphes entiers qui sont traduits mot à mot de l'article par Stéphanie M. Carrière, M. André, P. Letourmy, I. Olivier, & D. Mckey intitulé «Seed rain beneath remnant trees in a slash-and-burn agricultural system in southern Cameroon» publié dans *Journal of Tropical Ecology* (2002) 18: 353-374.

A case of plagiarism has been recently pointed out by Dr Pierre-Michel Forget from the Editorial Board of the *Journal of Tropical Ecology*. This case involves the paper by Valentin S. Pangou, A. G. Zassi-Boulou, Th. Bouki & G. Lechon entitled "Evaluation de la pluie de graines d'arbres isolés dans les cultures vivrières en région de forêt tropicale humide du Mayombe (Congo Méridional)" published in *Candollea* (2009) 64(2): 219-235. This paper includes whole paragraphs that were translated words by words from the paper by Stéphanie M. Carrière, M. André, P. Letourmy, I. Olivier, & D. Mckey entitled «Seed rain beneath remnant trees in a slash-and-burn agricultural system in southern Cameroon» published in *Journal of Tropical Ecology* (2002) 18: 353-374.

We would like to remind that even if reviewers and editors have ethical responsibility towards the global scientific community, the authors are the cornerstones of science and expected to conform to ethical practices when submitting their papers (CARRAWAY, 2009).

We deeply regret such an unpleasant case and hope that it will not happen anymore.
