The increased and unforeseen time demands in our daily professional jobs and commitments (teaching in-person classes online, restructuring research plans, etc.) has seriously affected the time available for the editors to accomplish the tasks of producing the journal. Additionally, reviewers have faced similar challenges and time-constraints. This has led to significant delays with the journal this year. I am truly sorry for these delays and any problems they have caused for our authors, members, and subscribers.

Volume 43 - Issue 1 was completed in the spring of 2020, but remaining Issues have been behind schedule. We are pleased to provide Issue 2 here, and Issues 3 and 4 are in the final copyedit process as you read this. We will be producing Volume 44 2021 beginning this spring as soon as the backlog of 2020 is completed.

I offer my thoughts and condolences to those who have faced serious illness, lost employment, or lost loved ones during these trying times. Thank you for your patience, and especially for all of you who work to ensure the conservation and appreciation of waterbirds around the world!
