ERRATUM

There is an error in the article of Florida Entomologist 98(2): 456–463, i.e., Lahey, Zachary and Philip Stansly—An updated list of parasitoid Hymenoptera reared from the *Bemisia tabaci* species complex (Hemiptera: Aleyrodidae). In Line 2 of Section *Encarsia* Förster (Chalcidoidea: Aphelinidae) on Page 459, the correct number of described species is 430 (not 450).

Furthermore, in Line 2 of Section *Metaphycus* Mercet (Chalcidoidea: Encyrtidae) on Page 460, the order Hemiptera could be added in parentheses after the superfamily Coccoidea. Redundant listings of the genus names *Encarsia* and *Eretmocerus* in the 1st column of Table 1 could be deleted.
