The following Cases are now closed:

**Case 2870:** *Xerophila geyeri* Soós, 1926 (currently *Trochoidea geyeri*; Mollusca, Gastropoda): proposed conservation of the specific name. Edmund Gittenberger. (Acknowledgement of receipt published in BZN 50 (1): 2; Case published in BZN 51 (2): 105; Comments published in BZN 51(4): 336; 338, 52 (2): 176, 52 (3): 259, 52 (4): 331, 53 (1): 43; 43.). Following discussion within the Commission that the application is now obsolete due to a transfer in the generic classification of *Xerophila geyeri* Soós, 1926 from *Trochoidea* Brown, 1827 to *Xerocrassa* Monterosato, 1892 in 1995, the Case is now closed.

**Case 3764:** *Cuvierina columnella*, *C. atlantica*, *C. spoeli* (Mollusca, Gastropoda, Euthecosomata). Jeannine Rampal. (Acknowledgement of receipt published in BZN 75: 3; Case not published). Following discussion with the author, the Case is now closed.

**Case 3814:** Proposed conservation of usage of the name *Mylothris agathina* Cramer, 1779 (Lepidoptera, Pieridae). Haydon Warren-Gash. (Acknowledgement of receipt published in BZN 76: 166; Case not published). Following discussion with the author, the Case is now closed.

**Case 3817:** *Turdus ustulatus* Nuttall, 1840 (currently *Catharus ustulatus*; Aves, Passeriformes, TURDIDAE): proposed conservation of prevailing usage by designation of a neotype. Matthew R. Halley. (Acknowledgement of receipt published in BZN 76: 166; Case not published). Following discussion with the author, the Case is now closed.
