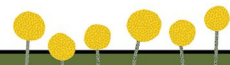

In the Diagnosis section for ‘Arctic subregion LeConte (1859)’ (p. 204, p. Q), an additional closing parenthesis was included in the wrong place (after ‘Nunavut’). The text should be corrected as follows:

Alaska (including the St Lawrence, Diomedes and Aleutian Islands), northern Canada (Yukon, Northwest Territories and Nunavut, northern parts of British Columbia, Alberta, Saskatchewan, Manitoba, Ontario and Quebec, and Newfoundland and Labrador) and Greenland.

In the reference list, Wallaschek 2015 should have been deleted because it was a duplication of Wallaschek 2015a.

These errors have been corrected in the version that is available online. We apologise for the errors and any confusion this may have caused.
